It is hereby notified that, the Regular/Supplementary Theory Examinations for First, Second and Third year of **B.A./B.Com./B.Sc./B.Sc (Home Science)/BA(OL)/BBM/BCA/B.Mus/B.Dance** and Pre-Degree in Oriental Learning examinations will be conducted during March/April-2011 tentatively as per the Academic schedule as detailed below:

1. English online Practical Examinations for I and II year Students from 24.01.2011.
2. Other Practical Examinations from 10-02-2011.
3. Theory Examinations from 14-03-2011.

However, the detailed scheme of Examinations for all the courses will be notified in due course.

The Last date for receipt of filled-in examination applications for March/April-2011 examinations from **Regular/Supplementary candidates is fixed as 15-12-2010**, so as to reach the concerned Principal's office and in turn the principals should forward the same to the Controller of Examinations, S.V.University on or before **20-12-2010**, so as to enable the Examination Branch for conducting the English on Line and other Practical Examinations as per the scheduled dates effectively on smooth lines.

**The Examination applications received after 21-12-2010 from Regular candidates will not be entertained at any cost.**

However, Supplementary candidates may send their Examination Applications following the Graded penalty as furnished below:

Between 21st and 22nd December, 2010 ..... Rs.35/- )

Between 23rd and 30th December, 2010 ..... Rs.100/- ) as penalty

The Examination application forms will be supplied from 30.11.2010 onwards. The Principals of the respective colleges may obtain the required number of applications on submission of request letter addressed to the Controller of Examinations, S.V.University, Tirupati, along with No Dues Certificate obtained from Deputy Registrar (Academic) and Deputy Registrar (Special Cell) to the effect that the total fees relating to Return of Matriculates, Recognition and Development fee has been paid to the Academic Branch and fees relating to IUTF, IUCFF & ICTF has been paid to Special Cell Branch.

The Examination applications can also be obtained from the University Enquiry counter on production of evidence by the supplemental candidate for having paid the examination fee.
